### INTRODUCTION

- ▶ This prospectus contains procedure for admission to all seats other than those which may be filled up by allotment by Commissioner of Entrance Examinations, Govt. of Kerala.
- ▶ This prospectus is subject to modification/addition/deletion as may be deemed necessary by the management of the College subject to further orders, if any passed by appropriate authorities/courts of law.



# CRITERIA OF ELIGIBILITY FOR ADMISSION

## NATIONALITY

Candidate must be Citizens of India.

## ACADEMIC REQUIREMENT

Pass in Higher Secondary Examination for the Board of Higher Secondary Education of Kerala or an examination recognized equivalent thereto with at least 60% marks in Mathematics separately and 60% mark in Mathematics, Physics and chemistry/equivalent subjects put together or equivalent grade.

Rounding of the percentage of marks to the nearest whole number is not permitted.

## ENTRANCE EXAMINATION

Candidate should qualify in the Engineering Entrance Examination conducted by the Commissioner of Entrance Examinations, Government of Kerala.

# HOW TO APPLY

Online mode: visit college website [www.mgmits.ac.in](http://www.mgmits.ac.in), fill the application form online and upload the scanned copy of important certificates asked and pay the application fee ₹500/- online through the online payment gateway and complete the application process. The candidate can take a print out of the final submitted application for reference and carry the same on the day of admission.

The candidate can visit the college and pay ₹500/- towards cost of application. The admission team will assist in filling the application online in the college itself. The candidate can take a print out of the final submitted application for reference and carry the same on the day of admission.

# PROCEDURE FOR SELECTION

## PREPARATION OF COMMON MERIT LIST AND ALLOTMENT OF SEATS

Subject to any orders that may be passed by the Competent Courts, admission will be only on the basis of inter-se-merit determined by adding marks obtained in the entrance examination conducted by the Commissioner for Entrance Examinations and Marks obtained for Mathematics, Physics and Chemistry/equivalent subject in the qualifying examination. The marks of the Engineering Entrance Test and Qualifying Examination will be apportioned in the ratio 50:50 Merit list for the different categories will be published in the Website([www.mgmits.ac.in](http://www.mgmits.ac.in)) of the College. Selection will strictly be in the order of merit. Selected candidates will not be intimated by post and they are advised to refer to the website and appear for the interview and final selection without fail.

## DATA VERIFICATION

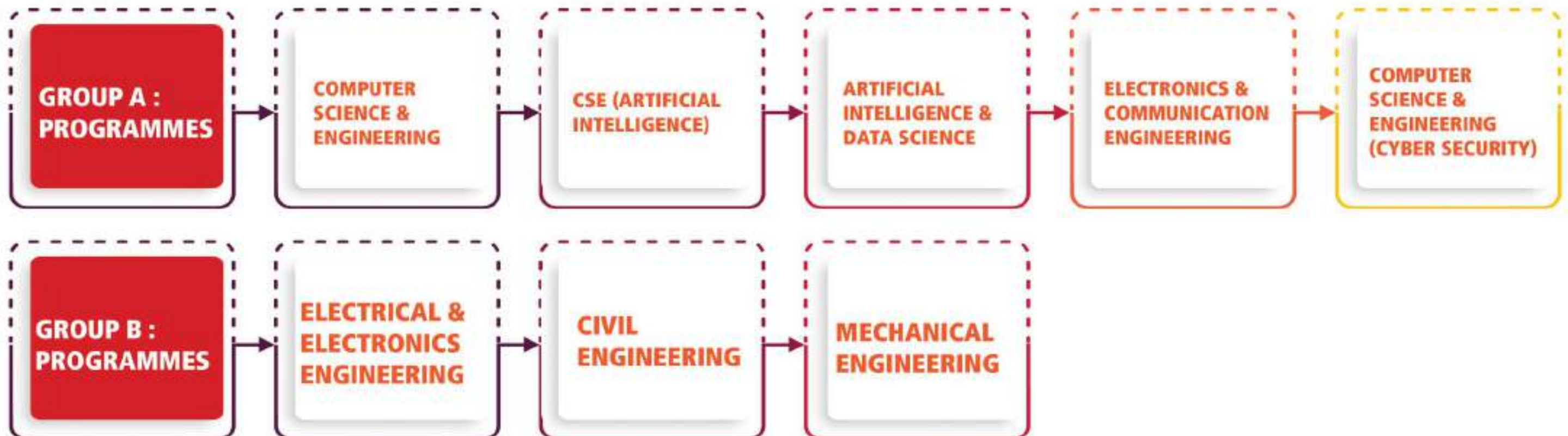
Details of all applications received including marks will be published in the website of the College ([www.mgmits.ac.in](http://www.mgmits.ac.in)) on the appointed date. Candidates are advised to verify the same and rectify entry mistakes, if any, with in the stipulated time limit. Further request for correction will not be entertained.

## PERCENTAGE OF SEATS SET APART UNDER VARIOUS HEADS

- ▶ 50% of the total intake is set apart for Centralized allotment by the Commissioner for entrance examination (CEE), Govt. of Kerala.
- ▶ 15% seats under NRI quota are given to children of NRI , provided candidates having minimum 80% marks in mathematics and 80% marks in mathematics, physics and chemistry / equivalent subjects put together for HSE/CBSE/ISC and other boards, are eligible for seeking admission under this category.
- ▶ 5% of the seats in each branch will be set apart for the children of employees of MUTHOOT GROUP. If there are not sufficient candidates in any branch in this category, such seat will be reverted that to the open merit.
- ▶ Management will be free to limit the admission to any particular rank from the CEE Rank list even if there are vacancies.
- ▶ Furnishing false information particulars would result in the forfeiture of candidature as well as cancellation of admission to the course if admitted and in addition, will attract the relevant provisions of criminal law of the country.
- ▶ One seat is reserved for children of BPCL, Cochin Refinery employees in each branch of 60 students.
- ▶ One seat is reserved for students, who have performed exemplary in various sports at least in state level or above, in each branch of 60 students.

## OPTION REGISTRATION/CONFIRMATION PROCEDURE WHILE TAKING ADMISSIONS AT COLLEGE

The applicant can exercise any of the 2 options while confirming admission at MITS.

### A) FREEZE OPTION :

Applicant opting Freeze option will have to fill in the prescribed Freeze option form, remit a **Freeze option confirmation fee of Rs 50,000/-**. This amount will be adjusted to the fee payable during the final admission process. Such applicants will also be eligible to be considered for Scholarships offered by the Muthoot Group. However, a student opting for the Freeze option and cancelling thereafter will lose the entire Freeze option confirmation fee.

### B) FLOAT OPTION :

Applicants opting Float option will have to fill in the prescribed Float option form, remit the entire fee of **Rs. 86,800 (Govt. Quota/Group B Management Merit Quota Programs) or Rs 1,35,800 (Group A Programs Management Merit Quota) + Rs 10,000 (Caution deposit) + Rs 2370 (Onetime fee)+Rs.5000(SETC)**. Such applicants **will NOT be eligible** to be considered for Scholarships offered by the Muthoot Group in any year. However, an applicant opting for the Float option can exit any time before the last date of admissions/commencement of classes stipulated by AICTE/CEE. In such cases, a cancellation fee of Rs 1000/- will be deducted and the entire remaining money will be returned as per the cancellation rules laid down by CEE/Govt. from time to time

In fee Category 1 & 2 combined, a **maximum of 18 seats** (9 in Management quota & 9 in Govt. Quota )will be allocated in a batch of 60 in Group A. , Category 1 & 2 combined, a **maximum of 24 seats** (12 in Management quota & 12 in Govt. Quota )will be allocated in a batch of 60 in Group B. If there are more than 18 students in Group A and 24 students in Group B, KEAM rank will be used to sort for scholarships in category 1 and 2. Once this allocation is over the student will be allotted to Category 3.

\* For continuation of scholarship please refer to the eligibility criteria given below. An academic year is comprised of TWO semesters. Semester fee payments are due before January 15th and July 15th of any year.



#Other fees include PTA fund/office & stationary charges/student enrichment program offered by MITS etc. irrespective of any category admitted.

Management Quota students will have to pay a onetime refundable caution deposit of Rs 10,000/-. There will be a one time payment of fees amounting to Rs.2370/- at the time of admission towards university fees. Skill Enhancement Training and Certification (SETC)\* Rs 5000/- per semester.

There are **different** categories of tuition fees (1, 2, 3, 4, 5 in Group A & Group B) under which candidates are admitted under Management Quota mentioned in the above table.

Candidates belonging to the first four categories (1,2,3,4) in Group A and five categories (1,2,3,4,5) in Group B are eligible for scholarships amounting to the difference of actual fee in Management Quota approved by Government from time to time.

### Criteria for Continuation of Scholarship

- ▶ Any student admitted in category 1 or 2 in MQ as per the above table **failing in at least one subject/not able to maintain minimum Cumulative Grade Point Average(CGPA) (7.5 CGPA in the university exam) in the semester** under consideration, will slide to cat. 3 in **both the groups** in the first instance (further max to Cat. 5 in Group A & Group B).
- ▶ Any student admitted in category 3 will slide to Cat. 4 and similarly admitted in Cat. 4 will slide to cat. 5 in MQ as per the above table, if the student **fail in any one subject/not able to maintain minimum Cumulative Grade Point Average(CGPA) (7 CGPA) in the university exam) in the semester** under consideration.
- ▶ If a student in **subsequent semester earns 8 CGPA, he/she can return to next immediate category in the first chance and subsequently to a maximum of Cat.3 in both the Groups**, but not to Cat.1, 2 . However if he/she is not maintaining **7CGPA** , he/she will not be eligible for the scholarship.

### Criteria of Eligibility for Admission

- ▶ Candidates must be citizens of India.
- ▶ Pass in Higher Secondary examination of Board of HSE of Kerala or an examination recognized thereto, with at least 60% marks in Mathematics, and 60% marks in Mathematics, Physics and Chemistry / equivalent subjects put together.
- ▶ Candidates should qualify in the Engineering Entrance Examination conducted by the Commissioner of Entrance Examination (CEE), Government of Kerala.

### Admission Procedure

- ▶ Subject to any orders that may be passed by the competent courts / authorities, admission will be only on the basis of inter-se merit determined by adding scores obtained in KEAM 2024 (for Mathematics, Physics, and Chemistry) conducted by CEE, and marks obtained for Mathematics, Physics, and Chemistry / equivalent subjects in the qualifying examination (board).
- ▶ The score of KEAM 2024 and qualifying examination will be apportioned in the ratio 50:50.
- ▶ Merit list for the different categories will be published in the website of the college ([www.mgmits.ac.in](http://www.mgmits.ac.in)).
- ▶ Selection will strictly be in the order of merit.
- ▶ Selected candidates will not be intimated by post, and they are advised to refer the website and appear for the interview and final selection without fail.

Selected candidates shall take admission at the appointed time and date in the college after paying the tuition fee and other fees to be paid, failing which the offer of admission will be cancelled.

#### REFUND/ADJUSTMENT OF FEES

- ▶ If the candidate who join our College in management quota, leave for whatever reason before the date of closure of admission, announced by the Govt. of Kerala, cancellation charges as stipulated in the govt orders will be payable.
- ▶ If the candidate leaves after the date of closure of admission, announced by the Govt. of Kerala, he/she has to pay the entire fee as stipulated in the govt orders.

An academic year is comprised of TWO semesters. Semester fee payments are due before January 15th and July 15th of any year.

**SCHOLARSHIP** : A student who scores **8 CGPA and pass in all subjects, but admitted under NRI quota** will be given **30% scholarship on NRI tuition fee**. However, if he/she fails or not able to maintain 7 CGPA, will again slide back to corresponding NRI semester fees.

### CRITERIA OF ELIGIBILITY FOR ADMISSION – NRI QUOTA

– **Group A Branches:** 80% marks separately in Mathematics and 80% Physics, Chemistry, and Mathematics put together in the 12th standard, for Qualifying examination(CBSE/ISC) OR attain 80% Marks for Mathematics individually and 80% put together in Physics, Chemistry & Mathematics, in the 12th standard(Terminal-evaluation TE), for Qualifying examination(State Board).

– **Group B branches:** 75% Marks for Mathematics individually and 75% put together in Physics, Chemistry & Mathematics, in the 12th standard, for Qualifying examination(CBSE/ISC) OR attain 75% Marks for Mathematics individually and 75% put together in Physics, Chemistry & Mathematics, in the 12th standard(Terminal-evaluation TE), for Qualifying examination(State Board).

### EXIT OPTION:

A student can opt to EXIT from NRI quota before 5 days after the publication of KEAM 2025 score/answer key whichever is earlier and will be reimbursed the entire amount after deducting Rs 1000 processing fee. However a student will be automatically considered for MITS management quota from NRI quota if he desires so and has to freeze the registration in MITS. (a) Persons of Indian Origin (PIO): shall mean the persons who are citizens of other countries (except Pakistan and Bangladesh) who at any time held an Indian Passport, or who or either of his parents or any of his grandparents was a citizen of India by virtue of the provisions of the Constitution of India or Sec 2 (b) of citizenship Act. 1955.

The board in which the candidates has undergone for his/her higher secondary education should be there in the list of approved higher secondary boards of Association of Indian Universities (AIU).

The applicant can exercise any of the 2 options while confirming admission at MITS.

### A) FREEZE OPTION :

Applicant opting Freeze option will have to fill in the prescribed Freeze option form, remit a **Freeze option confirmation fee of Rs 50,000/-**. This amount will be adjusted to the fee payable during the final admission process. Such applicants will also be eligible to be considered for Scholarships offered by the Muthoot Group. However, a student opting for the Freeze option and cancelling thereafter will lose the entire Freeze option confirmation fee.

### B) FLOAT OPTION :

Applicants opting Float option will have to fill in the prescribed Float option form, remit the entire fee of **Rs. 86,800 (Govt. Quota/Group B Management Merit Quota Programs) or Rs 1,35,800 (Group A Programs Management Merit Quota) + Rs 10,000 (Caution deposit) + Rs 2370 (Onetime fee)+Rs.5000(SETC)**. Such applicants **will NOT be eligible** to be considered for Scholarships offered by the Muthoot Group in any year. However, an applicant opting for the Float option can exit any time before the last date of admissions/commencement of classes stipulated by AICTE/CEE. ### TRAINING AND PLACEMENT CELL-CGPU

The Training & Placement Cell in the institute plays a pivotal role in counseling and guiding the students for their successful career placement which is a crucial interface between the stages of completion of academic program of the students and their entry into suitable employment. The key focus of the Career Guidance and Placement Unit (CGPU) is to prepare students for their placements/internships and to motivate them for successful performance in exams like GATE, CAT etc. At MITS students are expected to excel not in technical knowledge but also in leadership, interpersonal skills and other attributes.

The focus is not only on soft/social skills but the entire process is now streamlined to a multifaceted and structured curriculum. The potential skill set requirements are identified during early stages of the course and starting from second year we have a module at par with industry standards to ensure that they evolve to be future ready. Training is a continuous process and not limited to external interventions alone with having a dedicated internal team to coordinate. Also aptitude and problem solving skills are given equal weightage and a structure is defined to ensure that the students attending the campus schedule in the final year will be acquainted with the process.

The CGPU of the college intend to scale up the activities related with training and placements with a much broader framework than just limiting its activities to the normal mode of providing recruitment opportunities alone. In the long run, the unit intends to handhold the students with a holistic approach on career and life rather than just functioning as a placement support system which complements the education objectives of respective departments.

The Career Guidance and Placement Unit (CGPU) of the institute play a very important and key role in counseling and guiding the students of MITS for ensuring them good campus placement and for opening avenues for higher studies. It is executed through these following functions and responsibilities:

# RULES OF GENERAL DISCIPLINE, CONDUCT AND BEHAVIOUR
